

# 4.1 Description of first aid measures

#### 4.1.1 Inhalation


# **SECTION 5:** Firefighting measures

- 5.1 Extinguishing media
  - Extinguishing media: Extinguish with foam, carbon dioxide, dry powder or water fog.
    Unsuitable extinguishing media: Do not use water jet as an extinguisher, as this will spread the fire.
- 5.2 Special hazards arising from the substance or mixture
  - If heated or in cases of fire, pressure in a vessel will increase and container may burst.
  - Combustion products may include the following: carbon oxides (CO, CO2) (carbon monoxide, carbon dioxide) nitrogen oxides (NO, NO₂ etc.)
- 5.3 Advice for firefighters



# SECTION 8: Exposure controls/personal protection (....)





- Engineering Controls
- Appropriate engineering controls:

Provide exhaust ventilation or other engineering controls to keep the relevant airborne concentrations below their respective occupational exposure limits.

All activities involving chemicals should be assessed for their risks to health, to ensure exposures are adequately controlled. Personal protective equipment should conform to appropriate standards, be suitable for use, be kept in good condition and properly maintained.

- Eye Protection:
